

Personal Data Protection Act 2010

Kind Starfish Foundation (hereinafter referred to as “we” or “us” or “our”) values your privacy and works hard to ensure compliance with the Personal Data Protection Act 2010 of Malaysia.

This Privacy Notice explains how we collect and use your personal data.

A. Collection of Personal Data

Your personal data will be/is being collected, used and/or processed by us for amongst others, the following purposes:-

1. For registration and online application for “projects for Happiness”
2. For administrative purposes
3. To be used for our internal record keeping. (Projects for Happiness)

This personal data is obtained when you submit your online application for the “Projects for Happiness.” Your personal data will not be released to third parties without your consent.

B. Nature of Personal Data

Examples of personal data that we may collect directly from you:-

1. Name, age, gender, date of birth, identity card number/passport number, personal account number (to bank in the grant to the selected “Projects for happiness”)
2. Race, Ethnic, Origin, Nationality, University and study fields
3. Contact information including address, email address and phone number
4. Some general information of the beneficially NGO for “Projects for Happiness”

C. Disclosing Your Personal Data

We will keep your personal data confidential but you hereby consent and authorise us to disclose your personal data to the following categories of parties:

1. Any person to whom we are required to so by law or in response to a competent or government agency
2. Any related, affiliated and subsidiaries of ours
3. Government agencies, statutory authorities and industry regulators as required by law;
4. Our appointed service providers in relation to “Projects for happiness. (MyStartr.com)

D. Retention of Personal Data

We will retain your personal data for the period necessary to fulfil the purposes set out in Clause 1 hereinabove.

E. Security

We shall keep and process your data in a secure manner. We endeavour, where practicable, to implement the appropriate administrative and security safeguards and procedures in accordance with the applicable laws and regulations to prevent the unauthorized or unlawful processing of your personal data and the accidental loss or destruction of, or damaged to, your personal data.

F. Access and Correction to Your Personal Data

It is your right as a data subject to have access to your personal data in which you have provided to us and in this respect, you may ask for a copy of your personal data by contacting us at garshen.wong@khind.com

G. Your Obligation Regarding Your Personal Data

You are responsible for providing accurate, not misleading, complete and up-to-date information to us about yourself and any other person whose personal information you provide us and updating this personal data as and when it becomes inaccurate, misleading, incomplete and out-of-date by contacting us.
